The average Tanknology technician maintains 18 certifications.

Tanknology performs all UST and AST testing, services, inspections, and fuel quality filtration on-site at customer locations. Our service and inspection fleets are dispatched from regional offices nationwide, ensuring a qualified professional is always close to your facility. Our extensive list of services allows customers to combine multiple work items in a single visit, minimizing facility downtime and maximizing value and cost efficiencies.

Our People are our most crucial service resource. Tanknology has over 180 service technicians and inspectors who complete the industry's most advanced and comprehensive training course. Tanknology field employees, who operate in 43 states daily, comply with OSHA standards and drug-free workplace requirements. Technology is well represented in industry-wide groups, having representation on the American Petroleum Institute (API), Petroleum Equipment Institute (PEI), and National Fuels Institute boards and committees.

Systems are an integral aspect of our services at Tanknology. Technicians are connected via state-of-the-art technology. Inspectors operate with handheld wireless devices. Critical system data is recorded once, eliminating errors, and creating a permanent archive for regulatory and management purposes. Initially implemented in 2000, QualityFirst is Tanknology's quality control and assurance program. It is an essential element of our Quality Management System (QMS). Our QualityFirst program features many of the critical aspects of ISO 9001:2000, the recognized standard for quality management. QA/QC checks are conducted throughout the process, including on-site, at management review, and final QC at our Austin headquarters.

TANCS™, the "Tanknology Advanced Network for Compliance Services," is our proprietary customer portal for 24/7 access to all Tanknology compliance and inspection services data. Highly adaptable to customer requirements, TANCS is a relational database providing the most robust compliance data access system available anywhere. It provides detailed information about site data, services performed, schedules, test results, and inspections.

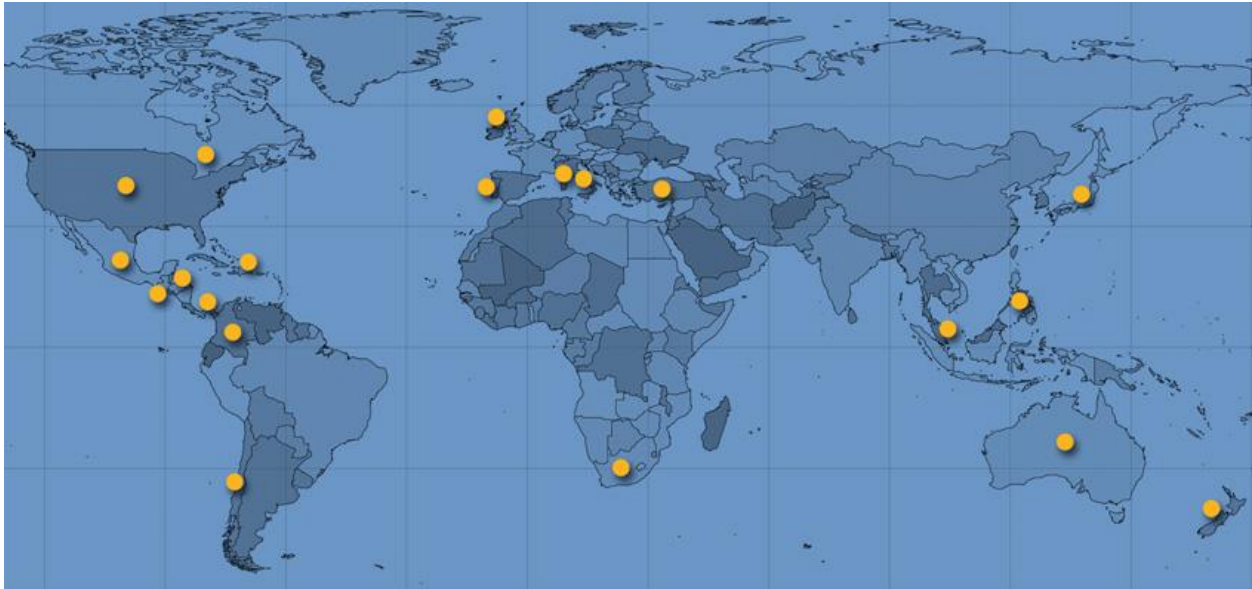
